- **ProVantage Kraftliner**

application (German Recommendation XXXVI): direct contact with dry, non-fatty and such foods which are peeled, shelled or washed before consumption and may also be used as secondary packaging. Dry, non-fatty foods with large surfaces may be packed by additionally using an appropriate intermediate packaging. Any further application is to be evaluated separately.

- **ProVantage Kraftliner Aqua**

application (German Recommendation XXXVI): direct contact with dry, non-fatty and such foods which are peeled, shelled or washed before consumption and may also be used as secondary packaging. Dry, non-fatty foods with large surfaces may be packed by additionally using an appropriate intermediate packaging. Any further application is to be evaluated separately.

- **ProVantage Aquaflute**

- **EcoVantage Kraft X**

application (German Recommendation XXXVI): direct contact with dry, non-fatty and such foods which are peeled, shelled or washed before consumption and may also be used as secondary packaging. Moreover, a contact with fatty foods is approved, provided that a transfer of aromatic hydrocarbons is not detectable for the respective application.
